December 29, 1924 - October 19, 2015

Reverend Howard Romaine was born in Chicago, Illinois to Guernsey and Lucy Romaine on December 29, 1924. He served the Lord faithfully until he was called home on October 19, 2015. Affectionately referred to as 'Rev' by all who knew him, was ordained into the ministry in 1965. His first pastoral appointment was with the Church of the Living God in Amarillo, Texas where he served for 15 years before being called to the New Zion Baptist Church in Borger, Texas. He remained until he retired to Atlanta in 2007, having touched many lives and won many souls. He was well known in the greater Amarillo area for his community service and giving nature. He and his close friend, Bob Grace, distributed holiday turkeys far and wide each year for decades. He often made personal, life-changing impacts on people by surreptitiously paying bills, buying supplies, and filling the financial gap for those in dire need. He also served as Chaplain for the City of Amarillo- Potter County.

Pastor Romaine was preceded in death by his parents and his son, Howard Romaine, Jr. He is survived by his wife, Willeane Romaine; 7 daughters: JoAnn Robinson, Lynell Romaine-Smith, Phyllis Glover, Sylvia Saunders, Renee Thompson-Symonds, Andrea Romaine, Karen Romaine Thomas and son-in-law Donald Thomas; 11 grandchildren, Michelle, Joey, Mia, Rahsan, Tomeka, Toya, Tammuz, LaKita, Kimberly, Jordan and Jada; and a host of great-grandchildren, nieces, nephews and other relatives.
